SOCIAL TRAINING & EDUCATION PROGRAM (STEP): adjudicated delinquent/dependent male adolescent, at least 13 years of age and at least in 7th grade. Admission to this level of care requires the client be able to respond to treatment in an open, residential environment. Their dysfunctional behavior is expected to be severe enough to require residential care and not be considered within the continuum of normal, troublesome adolescent behavior. The client's behavioral issues should have consistently interfered with the client's ability to address the three adolescent life tasks of peer group functions, school (work) functioning, and family or custodial services functioning. Clients in this program will present with behavioral issues related to delinquency/criminal behavior, social skill deficits, and corresponding treatment issues.

INTENSIVE DRUG & ALCOHOL TREATMENT PROGRAM (D&A): adjudicated delinquent/dependent male or female adolescent, at least 13 years of age and at least in 7th grade. Admission to this level of care requires the client having a history of substance use/abuse/dependence severe enough to necessitate clinically-managed, intensive, residential substance abuse treatment. The client's substance use/abuse/dependence should have consistently interfered with the client's ability to address the three adolescent life tasks of peer group functions, school (work) functioning, and family or custodial services functioning.

ABRAXAS I RESIDENTIAL MENTAL HEALTH SERVICES TREATMENT PROGRAM (ARMHS): male adolescent, at least 13 years of age and at least in 7th grade with a current psychiatric / psychological evaluation indicates a DSM-5/ICD-10 CM Diagnosis with severe impairment of functioning. Typically, these adolescents have manifestations of serious psychiatric and psychosocial needs including but not limited to: physical and/or sexual abuse, sexual deviant behavior, self-destructive behaviors, mood disorders, dissociative disorders, post-traumatic stress disorder, anxiety, attention deficit and hyperactive disorder, depressive and reactive attachment disorders, conduct disorder, oppositional defiant disorder, and organic brain dysfunction caused by prenatal exposure to alcohol or drugs. Multigenerational family issues including parental incarceration, substance abuse and addiction, child abuse, abandonment, and neglect are commonly present.

INTENSIVE OPEN RESIDENTIAL PROGRAM (IORP): adjudicated delinquent/dependent male adolescent, at least 13 years of age and at least in 7th grade. Admission to this level of care requires the client having a history of behavioral issues severe enough to necessitate staff-secure, intensive, residential treatment (e.g., significant aggression and/or violent behavior; habitual delinquent activity). The client's behavioral issues should have consistently interfered with the client's ability to address the three adolescent life tasks of peer group functions, school (work) functioning, and family or custodial services functioning.
